Property owners propose to dedicate an existing 60-ft road easement to Kendall County and reconstruct Poehnert Road in accordance with details in the exhibit provided and conditions placed on the proposed project by Commissioners Court. Kendall County Engineer's office would inspect the project construction to assure compliance with plan details and Commissioners Court conditions. Upon completion of a one year warranty period, the County would assume responsibility for maintenance of the roadway and associated drainage culverts. Storm drainage culverts, vertical alignment, and pavement thickness will comply with Kendall County Development Rules and Regulations.</p>

Letter of Intent
Poehnert Road Reconstruction

This letter is to serve as a narrative to the submission made to the commissioner's court, Kendall County Texas in regards to the Poehnert Road Reconstruction.

The existing Poehnert Road county section ends approximately 1.1 miles east of the intersection with the Waring-Welfare Road. This project is located at the end of the Poehnert Road, County Section and extends to the Bandera Electric sub-station and is to include the construction of approximately 5,500 linear feet of road, drainage culverts, and roadside ditches. The goal of this project is to construct a county road section that the court will accept and incorporate into the county road system.

Included within the scope of this project is the construction of a single paved road section that is to match the existing Poehnert County section in thickness, material and width. There are 6 existing culverts that will be analyzed and reconstructed if necessary in order to meet county standards.


The proposed road section does not meet the current county section standard in width of pavement or base. We are proposing to match the existing county road section for Poehnert Road, which has a pavement width of 18 feet and a base section of 20 feet. The section will however meet the current county standards in thickness, type, and placement methods. Also, the current alignment does not allow for several of the curves to meet the county minimum radius. We will provide the greatest radius that is feasible within the current alignment. All other standards and design criteria shall be in accordance with county design criteria.

We are asking for relief from the commissioner's court:

- Pavement width of 18 feet
- Pavement base width of 20 feet
- Trees located within the ROW
- Centerline minimum radius
- No roadway paint markings
