9. PUBLIC COMMENTS:

- David White expressed concern regarding the classification of Upper Cibolo Creek Road up to the 4mile point and asked for clarification as to when it became a Class 2 Road.
- Sharon McLaughlin, Master Naturalist, asked the court's approval to take the approximately ½ acre of
 land on Highway 87 coming from Fredericksburg into Comfort that the county currently leases to Ray
 Castro and improve it with a butterfly garden and all natural vegetation so that travelers will visually
 receive a welcome to Comfort. The Judge said that this would need to be addressed as a future agenda
 item requesting action.
- 10. No action was taken on lifting the burn ban; however, permits may be requested from the fire marshal.

- 12. A Public Hearing was held regarding the Plat Revision of Estancia at Thunder Valley Subdivision, Phase II, Lot 1 (22 acres) and Lot 49 (128 acres). The following people spoke:
 - John Kight said that he disagreed with the request as a re-plat of an existing subdivision and instead he
 considered it a new and separate subdivision that should have to comply with the density and minimum
 lot size rules of the county and Cow Creek Groundwater Conservation District.
 - Don Allee, County Attorney, said the request complies with the county requirements for it to be considered a Plat Revision.
 - Dub Smothers asked the court to review a Memorandum of Understanding between GBRA, the City of Boerne, CCGCD and Kendall County.

13. THE STATE OF TEXAS

COUNTY OF KENDALL It is ordered by the Commissioners' Court of Kendall County, Texas, to approve the Preliminary Plat for Estancia at Thunder Valley Subdivision, Phase II, which is approximately 150 acres and is the re-plat of Lot 1 (22 acres) and the previously vacated Lot 49 Greenbelt (128 acres).

Motion was made by Commissioner Reissig, seconded by Commissioner Lux, and carried by a vote of 4-0-1 with Commissioner Miertschin abstaining.
