1. The meeting was called to order with the Pledge of Allegiance to the United States and Texas flags.

The Judge commented on the November 4, 2008 Election as being an extraordinary and historic event where more than 17,000 Kendall County residents voted, which is roughly seventy-five percent of the registered voters. He complimented Rosie Reyes, the Elections Administrator, for a job well done and read the following letter which reflected the sentiments of many of those who commented to the Judge's office on the election: "Dear Judge Schroeder and the Court, I would like to compliment Mrs. Reyes and her election staff on the organization of the early voting process. It was run smoothly and easy by true professionals interested in helping the voting public. Again, thanks to her for a job well done."

- Rick Tobolka, Parks Director, announced the soft opening for Veterans Day at James Kiehl River Bend Park on Saturday, November 15, 2008, from 10:00 a.m. until 4:00 p.m. with activities recognizing County Veterans and how the park will be developed in the future.
- 7. No action was taken to reinstate the burn ban. It is still off.

COUNTY OF KENDALL It is ordered by the Commissioners' Court of Kendall County, Texas, to approve signing the "Agreement for loan of trailer purchased with Homeland Security Funds" in reference to a Citizens Emergency Response Team (CERT).

- 11. A Public Hearing was held regarding the establishment of a School Zone on Cascade Caverns Road for the Geneva School of Boerne. The following people spoke:
  - Brad Ryden, Head of School at the Geneva School of Boerne, said there are currently 385 students--K through 10<sup>th</sup> grade representing 220 families. On schooldays in the morning, there are approximately 150 cars coming on campus, including student drivers. Next year there will be 435 students---K through 11<sup>th</sup> grade.
  - David Brock, Geneva School of Boerne Board Member, said that policies have already been
    implemented on campus regarding parking, speed, and student drop-off. He said that the School Zone
    for the Geneva School would follow the same times and posted speed as set by the Boerne Independent
    School District for their School Zones.
