- 2. A Service Award was presented to James Hudson, Tax Assessor-Collector, for 20 years of service.

COUNTY OF KENDALL It is ordered by the Commissioners' Court of Kendall County, Texas, to approve the Minutes for July 13, 2009.

Motion was made by Commissioner Reissig, seconded by Commissioner Miertschin, and carried by a vote of 5-0.

COUNTY OF KENDALL It is ordered by the Commissioners' Court of Kendall County, Texas, to table action regarding the contract with Tyler Technologies for a Court Management Program for the County Clerk's office and the District Clerk's office.

Motion was made by Judge Schroeder, seconded by Commissioner Miertschin, and carried by a vote of 5-0.

11. PUBLIC COMMENTS:

- Joan E. Gindorf asked for consideration in funding for the County's libraries specifically for restroom facilities, meeting and storage areas.
- 12. No action was taken on lifting the burn ban. It is still on.

13. THE STATE OF TEXAS

COUNTY OF KENDALL It is ordered by the Commissioners' Court of Kendall County, Texas, to authorize the purchase of an ATV, trailer and fire fighting skid unit and additional equipment as needed up to a total amount of \$15,000.00.

Motion was made by Commissioner Lux, seconded by Commissioner Rusch, and carried by a vote of 5-0.

COUNTY OF KENDALL It is ordered by the Commissioners' Court of Kendall County, Texas, to approve the procedures necessary to allow the fire well on the Kuper property in Champee Springs Subdivision to be in service for firefighting.

Motion was made by Judge Schroeder, seconded by Commissioner Rusch, and carried by a vote of 5-0.

The following Public Hearing and Order are from the Supplemental Agenda:

- SA-1. A Public Hearing was held regarding the proposed Comprehensive Parks, Recreation and Open Space Master Plan to be in effect from 2009 to 2019. The following people spoke:
 - The Judge read an email from Kristie Denbow, President of the Kendall County Partnership for Parks, expressing support for the Master Plan.
 - Brent Evans thanked the County for their mulching program. He expressed support for the Master Plan noting a correction that the bond election passed by 62% not 55%; he provided copies of a September 2008 Compatibility Report comparing the Joshua Springs Parks & Preserve Development Plan to the Master Plan; he urged caution in park development saying that the most inexpensive park plan is one that is minimally developed; and he urged caution in setting precedents for what is to be allowed in the County park system.
 - John Benedict spoke in support of the Master Plan and suggested that a Summary of Accomplishments be added to what is submitted to the Texas Parks & Wildlife; changing the order of some of the objectives in the Plan presentation; and identifying the cultural resources within the park system.
 - Sharon Benedict spoke in support of the Master Plan and of passive and educational uses of the parks.
 - Duane Peterson asked that a percentage of the hiking trails be put into areas that are shaded and suggested using organizations such as the Boy Scouts to help create the trails. He also encouraged the consideration of handicap access to as much of the natural areas of the parks as possible.
 - Elaine Dill, grant writer for County parks, spoke about the purpose of the order of objectives and priorities and public input through the requirements of Texas Parks & Wildlife.
 - Commissioner Miertschin presented an email from James Northrup suggesting that the 3,600-acre 3Ks Ranch, which has been willed as a State Park, be listed as a part of the Master Plan.

SA-2. THE STATE OF TEXAS
