 - Becky Eterno said the request is only for the County to maintain the road as a good gravel road for dust reduction; she said the request is not for a bigger or a paved road
 - Sandra Tietze added that road upkeep would be for the safety of the residents and for emergency vehicles
 - Gerald Froemming also said that the road is such that at its end it blends into a driveway and looks like it continues on when it does not
 - · Steve Driskill said that where the road washes out makes travel a serious safety issue
 - Tim Lamberson said that in 1978, land was conveyed for the road width to be 25 feet, which is more than is needed for a 3rd class road

- 29. Jeff Fincke, Emergency Management Coordinator, gave a presentation on a digital radio system as a proposed use of the State Homeland Security Program (SHSP) grant funds.
