  - a new truck for Parks Department has been ordered Joshua Springs Park & Preserve:
    - qualifications, scope and fee for professional landscape services associated with the Texas Parks & Wildlife grant are under review
    - · restroom facility schematics for the Ring Mountain house are under review
    - roadwork regulatory and compliance issues are being addressed
    - boundary work for defining the approximately 80-acre open space/natural area has been completed
- 16. Cathy Morris, Associate Judge of the Child Protection Court of South Texas, gave an overview of the origins, functions, and evolution of the Child Protection Court in Texas.
  - associate judges cover multiple counties
  - child protection suits are filed by the Department of Family and Protective Services or by Child Protective Services (CPS)
  - associate judges travel to the cases in other counties so the attorneys and families do not have to travel
  - the goal is for children to achieve permanency more quickly and receive a higher quality decision because the judges specialize in only these type cases
  - currently in Texas, there are 17 Child Protection Courts in 130 counties with 12 associate judges, 6 assigned judges, 13 court coordinators, and 4 court reporters
  - in fiscal year 2008, over 22,000 hearings for these type cases were heard
  - the Office of Court Administration, a state agency, pays the salaries for the associate judges, their staff and any necessary equipment
  - Kendall County was chosen as the host county for Judge Morris by District Judge Stephen Ables. The host county must provide office space, telephone and fax lines
