- 16. Phillip Bell and Paul Urban, Kendall County Representatives on the Economic Development Corporation (EDC) Board of Directors, presented a report of activities for 2009. Approximately 180 new jobs will be created through EDC projects:
  - Texas Capital Grant for Albany Engineering Corporation
  - Census of the County for Federal Stimulus Funds
  - Red Apple program with Texas Tech University
  - Tax Abatement Policy
  - Creation of the Manufacturers Association for Kendall County
  - Projects still in work: Texas Star Nut Company, Red Apple Plus with Angelo State University, Green Star Corporate Office relocation, bringing in certain franchise restaurants, and Project 500 to create 500,000 feet of retail space
