COUNTY OF KENDALL It is ordered by the Commissioners' Court of Kendall County, Texas, to approve the request for relief in Cordillera Ranch Subdivision, Unit 207B, as follows: (1) use a prime coat under 1-½" hot mix asphalt pavement in lieu of a one course surface treatment; (2) use a 6" roll curb on Clubs Drive in lieu of the standard 7" curb; (5) use a 29-foot paved surface for Clubs Drive in lieu of a 36-foot paved surface; and (6) allow utilities to be placed within the right-of-way in lieu of them being in a utility easement.
