Motion was made by Judge Lux, seconded by Commissioner Rusch, and carried by a vote of 4-0.

A Public Hearing was held regarding the application filed by The Comfort Village LTD for the proposed Plat Revision for Outlot 53A-1A, Town of Comfort, filed in Volume 5, pages 269-270 of the Plat Records of Kendall County, Texas. The proposed Plat Revision would create two Outlots 53A-2A (15.198 acres) and 53A-3A (26.028 acres) from Outlot 53A-1A (41.22 acres). No one spoke.

  - 3. Duties and responsibilities of the County Sheriff's Office
