# 17. (10:08 a.m.) THE STATE OF TEXAS

COUNTY OF KENDALL It is ordered by the Commissioners' Court of Kendall County, Texas, that the property tax rate be increased by the adoption of a tax rate of \$.4127 per \$100.00 taxable value which is effectively an 8.22 percent increase in the tax rate. The Debt Service Rate is \$.066213 and the Maintenance and Operations Rate is \$.346487, both rates are per \$100.00 of taxable value.

THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE.

THE TAX RATE WILL EFFECTIVELY BE RAISED BY 1.18 PERCENT AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY 53 CENTS.
