ELIGIBILITY FOR SERVICES

- A youth between the ages of 3-17
- Have a mental health diagnosis
- Have serious problems in daily life functioning due to psychiatric symptoms
- In addition, a child is eligible for services, if:
- Their mental health problems put them at risk of being removed from their preferred living or child care environment
- The child is enrolled in a school special education program because of serious emotional problems

Hill Country MHDD Centers accepts Medicaid and Children's Health Insurance Program (CHIP). If the child has no health care coverage, fees will be assessed on the basis of their family's income.

SOME MENTAL HEALTH WARNING SIGNS

A CHILD/ADOLESCENT IS TROUBLED BY FEELING:

- Sad and hopeless for no reason
- Very angry most of the time
- > Worthless or guilty often
- > Anxious or worried often
- > Unable to get over a loss
- > Extremely fearful
- Constantly concerned about physical problems or physical appearance
- Frightened that his or her mind either is controlled or is out of control

A CHILD/ADOLESCENT EXPERIENCES BIG CHANGES, SUCH AS:

- > Declining school performance
- > Lose of interest
- > Changes in sleeping/eating patterns
- > Avoiding friends/family (alone)
- > Feeling life is too hard to handle
- Hearing voices
- Experiencing suicidal/homicidal thoughts

A CHILD/ADOLESCENT EXPERIENCES:

- Poor concentration and is unable to think or make up mind
- An inability to sit still or focus attention
- A need to wash, clean things, or perform certain routines hundreds of times a day
- > Racing thoughts
- Persistent nightmares

A CHILD/ADOLESCENT BEHAVES IN WAYS THAT CAUSE PROBLEMS:

- > Using alcohol or other drugs
- Eating excessively, purging, abusing laxatives, dieting and/or exercising obsessively
- Violating others rights/breaking the law with no regard for others
- Setting fires
- Doing things that can be life threatening
- Killing animals

Developmental Disability

Services and supports provided for individuals with pervasive developmental disorder which is usually a permanent condition originating sometime between birth and age 18. Individual typically has IQ of 70 or below and behavior does not meet level of personal independence and social responsibility expected for individual's age and culture.

Services include day programs, residential services, respite, service coordination, community supports and supported employment

Early Childhood Intervention

Serves families with children age 0 to 3 years by providing services designed to assist parents in addressing the needs of young children with delayed development and/or atypical development.

Substance Use Disorder

A 16 week treatment program designed for adult clients who do not require the more structured environment of residential treatment to maintain sobriety. Groups meet 2 times a week and individual sessions are required at least 2 times a month.

YES Waiver Program

The YES (Youth Empowerment Services) Waiver is a 1915(c) Medicaid Home and Community-Based Services Waiver that allows for more flexibility in the funding of intensive community-based services to assist children and adolescents with Severe Emotional Disturbances (SED) to live in the community with their families.

Be between 3-18 years of age; Have serious functional impairment or acute severe psychiatric symptoms as indicated by:

- Risk of Self-Harm
- Disruptive or Aggressive Behavior
- Family Resources
- School Behavior

Adult Mental Health

Treatment of Major Depression, Bipolar and/or Schizophrenia Disorders focusing on an individual's outcomes, selected services, tools, and strengths in order for them to recover

Services include Case Management, Counseling, Pharmacological Management, Medication Training and Support, Psychiatric Rehabilitation, Skills Training, Engagement Activities, Supported Employment and Supported Housing

Crisis Stabilization Unit

A 16 bed adult acute care unit which focuses on acute, short-term crisis stabilization providing Psychiatric, Psychological and Nursing Services.

Children's Mental Health

Treatment for youth, ages 3 through 17, who have a mental health diagnosis or have serious problems in daily life functioning due to psychiatric symptoms

Services include Skills Training, Family Skills Training, Counseling, Case Management, Family Partner, Pharmacological Management, Parent Support Group, Medication Training and Support, and Engagement Activities



ADDITIONAL SERVICES

Children's Crisis Respite

Temporary emergency respite for children with behavioral health issues designed to help the child stay in a community setting.

Co-occurring Psychiatric and Substance Use Disorder (COPSD)

Treatment to assist individuals living with a mental illness and substance use disorder in their recovery by addressing issues relating to both their mental illness and substance use.

Developmental Disability Crisis Services

Provides behavioral assessment to determine cause of behavioral crisis and develops and teaches primary caregivers on appropriate interventions to limit recurrence of behavior.

Family Partner

Family Partners are individuals with lived experience who provide mentoring and support to primary caregivers who have children dealing with behavioral issues; introduces the family to the treatment process; models self-advocacy skills; assists in identifying natural supports; and provides non-clinical skill training.

Mobile Crisis Outreach Teams (MCOT) Hays, Gillespie / Kerr, Comal, and Val Verde Counties

Crisis Assessment, Treatment Placement, and Preventive Crisis Support Services delivered by a dedicated team for crisis services.

The team also assists recovering individuals regain stability and resiliency in order to avoid a crisis relapse by providing temporary supports and follow-up care.

Trauma Informed Counseling

Therapy designed to treat posttraumatic stress and related emotional and behavioral problems. Therapy can treat individuals who have experienced physical and sexual abuse, severe bullying, warfare, traumatic injuries, natural disasters, and other events.

Veteran Outreach

Community based wrap around services provided by Veterans for Veterans and their families dealing with issues such as readjusting to everyday life after deployment or dealing with trauma from active service.

Whole Health Peer Support

Individuals with true life experience who are examples of recovery and help individuals receiving services maintain hope and learn to identify and deal with symptoms related to their illness as well as to understand the importance of their overall health care.

What is Recovery?

"A deeply personal, unique process of changing one's attitudes, values, feelings, goals, skills, and/or roles. It is a way of living a satisfying, hopeful, and contributing life even with limitations caused by illness" (Anthony, 1993).

Recovery Model

- Builds on current strengths of individual.
- Teaches skills to help reach "real life" goals.
- Promotes recovery within limitations of the disease through encouraging independence.
- Focuses on community integration.
- Focuses on whole-person and not just the disease.
- Requires participation of individuals served.
- Services are determined by individual's needs

STATE OF TEXAS KENDALL COUNTY

KENDALL COUNTY ORDER NO. 02-27-2017A

AN ORDER ADOPTING REVISED RULES CONCERNING THE USE OF THE DOG PARK AT JOSHUA SPRINGS PARK AND PRESERVE

WHEREAS, the Commissioners Court of Kendall County desires to continue to make available to the public for allowable purposes the Dog Park located on County owned land at Joshua Springs Park and Preserve; and

WHEREAS, the Commissioners Court recognizes that the Dog Park is public property and the public should be allowed to use such property provided that the use is lawful, does not constitute a nuisance, does not interfere with the use and enjoyment of the property by others, does not cause harm to others or their property, does not cause damages to County property, and does not interfere with the conduct of County business; and

WHEREAS, rules are necessary to insure personal safety, public safety, protection of County owned property, and protection of personal property; and

WHEREAS, the Commissioners Court previously adopted rules concerning the use of the Dog Park and finds it is in the best interests of the public that the rules be revised;

NOW, THEREFORE, BE IT ORDERED BY THE COMMISSIONERS COURT OF KENDALL COUNTY, TEXAS, THAT THE FOLLOWING RULES CONCERNING THE USE OF THE DOG PARK ARE ADOPTED AND EFFECTIVE IMMEDIATELY:

- Persons entering the park premises and bringing children and/or pets into the park do so at their own risk. Kendall County is not responsible for injuries to persons or dogs or for damages to or theft of personal property occurring in the park or on county property adjacent to the park. Kendall County is not responsible for the behavior of any dog in the park or in the county property adjacent to the park.
- 2. Dogs must be under voice control of their handlers at all times while in the park.
- 3. Owners must carry a leash with them at all times while in the park.
- 4. Dogs must be leashed at all times while entering and exiting the park.
- 5. Dogs shall wear a collar with owner identification and have current rabies, vaccinations, and applicable license tags clipped to their collars at all times to be allowed in the park.
- 6. No dogs under the age of 4 months are allowed in the park.
- 7. Children under the age of 13 must be accompanied by an adult and supervised at all times while in the park.
- 8. Owners are solely responsible for injuries and/or damages caused by their dogs while in the park.
- 9. Aggressive dogs are prohibited from entering the park. Any dog showing signs of aggression shall be removed from the park. Any dog that engages in fighting will be removed from the park and not allowed to return.

- 10. Dogs in heat are prohibited from being in the park.
- 11. No bathing of dogs is allowed within the park.
- 12. Food, smoking, or use of tobacco in any form including e-cigarettes, is prohibited in the park.
- 13. One person shall not bring more than 3 dogs into the park at the same time.
- 14. No glass containers are allowed in the park.
- 15. All dogs shall be disease and parasite free to be allowed in the park.
- 16. The person or persons bringing a dog into the park are responsible for cleaning up any waste from the dog and deposit the waste in the containers provided.
- 17. The person or persons bringing a dog into the park shall fill in any holes made by the dog.
- 18. Gates to the park shall be kept closed at all times, except while entering or exiting the park.
- 19. Violation of park rules will result in removal from the park and subject the violator to issuance of a citation.

Reporting of Bites or Injuries: Bites or injuries should be reported to Kendali County Animal Control IMMEDIATELY at (830) 537-3430.

Administration. The County Parks Department is responsible for enforcement and administration of this Order.

Penalty Clause: Violation of any provision of this Order is a misdemeanor punishable by a fine not to exceed two hundred and no/100 dollars (\$200.00) for each violation.

Severability Clause: If any part of this Order should be found invalid or unconstitutional, the validity of the remainder hereof shall not be impaired.

KENDALL COUNTY ORDER NO. 02-27-2017 B

AN ORDER AUTHORIZING COMMISSIONERS AND COUNTY DEVELOPMENT ENGINEER OR COUNTY ENGINEER TO APPROVE AMENDING PLATS

WHEREAS, the Kendall County Development Rules and Regulations, Subsection 209.2000 provides that an Amending Plat may be approved and recorded and is controlling over a preceding plat without vacation of the preceding plat if the amending plat is signed by the applicants and is solely for one of the following or more purposes:

- (1) To correct an error in a course or distance shown on the preceding plat.
- (2) To add a course or distance that was omitted on the preceding plat.
- (3) To correct an error in a real property description shown on the preceding plat.
- (4) To indicate monuments set after the death, disability, or retirement from practice of the engineer or surveyor responsible for setting monuments.
- (5) To show the location or character of a monument that has been changed in location or character or that is shown incorrectly as to location or character on the preceding plat.
- (6) To correct any other type of scrivener or clerical error or omission previously approved, including lot numbers, acreage, street names, and identification of adjacent recorded plats.
- (7) To correct an error in courses and distances of lot lines between two adjacent lots if:
 - (a) both lot owners join in the application for amending the plat; and
 - (b) neither lot is abolished; and
 - (c) the amendment does not attempt to remove recorded covenants or restrictions; and
 - (d) the amendment does not have a material adverse effect on the property rights of the other owners in the plat.

- (8) To relocate a lot line to eliminate an inadvertent encroachment of a building or other improvement on a lot line or easement.
- (9) To relocate one or more lot lines between one or more adjacent lots if:
 - (a) the owners of all those lots join in the application for amending the plat; and
 - (b) the amendment does not attempt to remove recorded covenants or restrictions; and
 - (c) the amendment does not increase the number of lots.
- (10) To replat one or more lots fronting on an existing street if:
 - (a) the owners of all those lots join in the application for amending the plat; and
 - (b) the amendment does not attempt to remove recorded covenants or restrictions; and
 - (c) the amendment does not increase the number of lots; and
 - (d) the amendment does not create or require the creation of a new street or make necessary the extension of county facilities.

WHEREAS, the Kendall County Development Rules and Regulations, Subsection 209.2100 provides that notice, a hearing, and the approval of other lot owners are not required for the approval and issuance of an amending plat.

WHEREAS, the Kendall County Development Rules and Regulations, Subsection 209.2000 provides that the Commissioners Court may approve such amending plats.

WHEREAS, the Commissioners Court desires to provide an expedited process for approval of such amending plats in order to save the citizens of Kendall County unnecessary delay and expense.

NOW THEREFORE, the following **ORDER** is adopted, effective immediately, concerning the approval of amending plats:

 The Commissioners Court hereby delegates to the Commissioner for the precinct wherein the property affected by an amending plat is located and the Development Engineer of Kendall County, and in the absence or unavailability of the Development Engineer, the County Engineer of Kendall County the authority to consider the approval or denial of an amending plat.

- 2. If an amending plat is approved by the Precinct Commissioner and the Development Engineer or County Engineer, the amending plat may be recorded and is controlling over the preceding plat without vacation of that plat. If the amending plat is not approved by the Precinct Commissioner and the Development Engineer or County Engineer, the applicant shall have the right to have the amending plat considered by the Commissioners Court in accordance with Subsection 209.2000, Kendall County Development Rules and Regulations.
- 3. In the event that prior orders adopted by the Commissioners Court contain provisions that are in conflict with the provisions of this Order, the provisions of this Order shall control.
